Annual Meeting Minutes 2019

CONGREGATIONAL CHURCH OF BOOTHBAY HARBOR ANNUAL MEETING JANUARY 27, 2019

The 253rd Annual Meeting, as announced by the Rev. Dr. Sarah Foulger, was called to order at 11:32 AM by the elected moderator, Bob Hilscher. There were approximately 65 members in attendance, over the 10% of the 335 active members needed for a quorum. Pastor Foulger led the group in prayer:

God of the seasons turning, another year has come and gone and once again we gather for the Annual Meeting of this Congregation. To this place we bring all the celebrations and hardships, the joys and the sorrows of the past 12 months. It has been a year of celebration for this congregation and we stand in awe of the ways in which you have blessed this church for 252 years. Here we pause to remember those whose lives we have celebrated as we said the last farewell of death. Here we remember the highlights of the year. Here we also gather to look forward to what the coming years have in store. As we meet and discuss the life and work of this part of your family, we pray that you would be a part of our discussion. May your Spirit move in our hearts, opening them to hear what each of us has to offer, bringing light to both possibilities and realities, drawing us always to consider what you would have us be and do in this time and place. Remind us that we are called to be bearers of Christ's life, light, and love to all we meet. Help us to live in such a way that we draw closer to your vision for us and journey faithfully in your Way.

These things we pray in the name of Jesus of Nazareth, the one we call Christ, in whose hope we gather together as a community. Amen.

Article I: To accept the minutes of the last Annual Meeting held on 1/28/2018. Barclay Shepard moved, and Russ Hoffman seconded the motion to accept the minutes of the last Annual Meeting. There was no discussion. The motion was approved unanimously.

Article II: To accept the Annual Reports of Committees. Becky Welsh moved, and Bill Harvey seconded the motion to accept the Annual Reports. A discussion proceeded to note a new system of keeping the data. We also neglected to include several new members, including Marion Coleman. And we mourn the loss of Leroy Yereance (2/8), Barbara Williams (6/14), Owen Pinkham (10/17), and June Stephens (3/20) among other. The motion was approved.

Article III: To act upon the Proposed Budget for the year 2019. The motion to accept the Proposed Budget for the year 2019 was moved by Ken Blasdell and seconded by Ginger Rickeman. Discussion was provided by Senior Trustee, Bob Hilscher.

- The investment transfer with income volatility from year to year (line 9), which is a transfer made at the end of the year to zero the budget. The amount this year used to be at 4% which was reduced this year to 3.5%. There was volatility regarding the inside maintenance and repair, (line 98-100) and because we prepaid a lot of the security work to strength the entrances and wiring for cameras in the future. There are concerns about the outside maintenance and repair (line 100), so the Trustees are planning for the worst and hoping for the best.
- Question: (Line 10). There was a large anonymous donation to be used for the Sunday School Program and music. There is a big jump expenditure (from the donation) in Committee and Program Section (line 74).
- Question: Cleaning Services (line 90) is similar to 2018 as we wait to see if there are increases from the service. We pay on an hourly basis week to week and we reimburse for supplies

- Question: Line 110, clarification of end of year bonuses. The Trustees need to budget for these expenses.
- Question: UCC Annual Expenses (line 63) is the membership fee for the Maine Conference.
- The capital campaign of 2018 was completed this year. The campaign was completed 100%. The campaign allowed us to pay the investment fund \$96,000, and everything else and still had a little money left over.

The Proposed Budget was approved unanimously.

Article IV: To act upon the proposed changes to the bylaws. Frank Helman and Sandi Leonard are available for questions. Wendy Wolf could not attend today. Neither Frank nor the community has seen the final version of the bylaws, so we cannot vote. A motion was made by Donald Duncan, which was seconded by Frank Helman to <u>table this action</u> until the next congregational meeting. The motion was approved but opposed by 1. No abstentions. The motion carries.

Article V: To elect Church Officers, Committee Members, and Delegates for the year 2018. The motion to accept the Report of the Nominating Committee for the January 2018 Annual Meeting was made by Ella Long and seconded by Frank Helman. Discussion: We are still looking for one more Deacon. Barclay Shepard's name was inadvertently omitted from the Hospitality Committee. AV Committee is a subcommittee of the Deacons. We still need volunteers for the AV Committee; we've been asking for a year. Skills necessary? Just be able push a button. Time required: meet every 2-3 months; need to take care of the system once a month (rotating). The motion to approve the Report of the Nominating Committee was approved unanimously.

Article VI: Bob Hilscher gave a report on the Safety Plan for the Church. Trustees and Deacons talked about church safety both in the worship service as well as throughout the building on a day to day basis. They received lots of input from Larry Brown and Police Chief Bob Hasch. Many members of the Trustees and Deacons went through CPR/AED training to handle medical emergencies. We are moving toward electronic doorways with the push of one button. Cameras: We need volunteers to monitor the cameras weekly during the service. It would be wise to implement the use of cameras. These discussions will continue in Deacons' and Trustees' Committee meetings. The wiring has been completed. They have talked to the police about how to get folks out of the church in an emergency and processes and procedures with the Sunday School. This is a journey, not a destination yet. Question: If there is a power outage, what happens? The doors will remain locked. The default is open, but it wouldn't default if there was a power outage. The back door is operated with a key or the keypad. However, in the last 16 years the church has only been without power for 3 hours. There was no vote taken or necessary.

Article VII: To recognize the Living Stones Awards. Each year Sarah likes to recognize the people who have gone the extra mile in the life of the church without repeating the same names each year. Sarah Foulger presented the heart-shaped stones which each awardee will receive. The following people/groups received the 2018 Living Stone Awards:

- The AV Team: Tom Dewey, Sue Goodrich, and Jeff Long have worked so hard and long hours this year to make to make this happen, especially when setting up.
- Susan Reynolds, who has moved us closer to ecological responsibility, with the addition of church mugs and plates that do not weigh a ton!
- Rich Humphrey, who stepped up at nearly the last minute to sing a solo in one of the too many memorial services last year.
- The Jewelry Table Crew brought back this year to the Christmas Fair: Barbara Zarpentine, Arlene Smith, Jeanne Whittier, Carolyn Schubert and others. It was a lot of detail work. Alice Mutch has been appointed the new chair of this committee for next year.

• The Mission Committee and Marty Helman for an amazing breakfast to raise funds for Hurricane Relief.

For 2018 Heavy Lifting Living Stone Awards:

- Alex Logan, who is stepping down as Treasurer after 14 years, I think, but will continue to help out and trained Jeff Long to take over as Treasurer.
- Bob Hilscher, who led the capital campaign and then led the Trustees and has now moved out of that important leadership role.
- Tom Dewey, for more than 20 years of service with the sound system and now the AV program to bring the church into the 21st century.
- Betty and Ted Repa, for 18 years of service, are now leading their last adult study.

Article VIII: To transact any other business as may properly come before the meeting. Bob Hilscher was requested to moderate the Annual Meeting again in 2020. No vote was taken.

At 12:06 PM Carol Cragin made a motion to adjourn which was seconded by Tom Dewey. The motion was approved unanimously.

Executive Committee

"It was the best of times; it was the worst of times..." On Sunday October 27, 2019, we said farewell to our beloved pastor, the Rev. Sarah Foulger, the first woman to serve as pastor in our 253-year history, and our longest serving pastor as well. We did this gracefully as a congregation, with laughter, with sadness, with good food, and with many expressions of love and deep gratitude for all she has done in her sixteen years at the Congregational Church of Boothbay Harbor.

Sarah's legacy to us is the gift of a healthy, thriving community of faith – one with strong, committed leaders, a church family that is happy to accept all comers, a lovingly refurbished church and fellowship hall, a sound financial base, and a culture of social justice and caring for each other and our community – here and worldwide.

The congregation has been very patient with the Executive Committee these last months as the Committee has worked to identify and hire the right Interim Minister to facilitate the church's grieving and transition. Our church has been very blessed during this time to have some very gifted preachers fill our pulpit: Tom Lenhart, Ken Bradsell, and Brian Donovan.

Happily, the Executive Committee has hired an Interim Minister who we believe is a good fit for our congregation, one who will not shy away from challenging us during our journey of self-discovery. The Rev Peter Ilgenfritz (pronounced Il-jen-fritz) will be coming to us on February 1, 2020. He is lately of Seattle, WA, where he spent 25 years team pastoring at the University Congregational United Church of Christ. Over time he served in all aspects of the church's life and leadership. This last year, Peter felt called to leave Seattle and he founded a ministry called Navigating Through Change. He is passionate about helping individuals and communities through transitions, and he is very excited to be coming to Boothbay Harbor.

Some of you may be wondering why an interim period is even necessary for a healthy church. The truth is, we need time to grieve for our retired pastor, and we also need to determine who we want to be going forward without Sarah. And most importantly, we need to do this as a unified church to ensure that our transition to a settled pastor is successful. The interim period usually lasts one to two years, during which the interim pastor helps us to explore our heritage, our mission, and what God is calling us to become. A Transition Committee will assist the Interim Pastor during this time and will use the church's collective explorations to update our Church Profile for the Settled Pastor Search.

Confirmed members of our *Transition Committee* are Peggy Pinkham, Barbara Fritz, Marianne Reynolds, Ken Fitch, and Bob Hilscher.

Also, during this time, the Executive Committee will be assembling the actual *Search Committee* for the Settled Pastor, so that this committee is ready to go when the Profile is complete. As Sarah begins a new stage in her life, we push off on our own voyage of self-discovery. May it be fruitful!

Diaconate

It has been an unusual and tumultuous year for our church, particularly in the latter half, and much has fallen to the Deacons to address. They have carried on with their primary duties of preparing the sanctuary for worship, preparing and serving communion, ushering, helping at memorial services, and setting the spiritual tone of our congregation. However, the retirement of our beloved Pastor Sarah and the nearing of Brian Donovan's long-standing goal to attain the ministry significantly increased Deacon responsibilities, especially for the co-chairs.

Continued oversight of Brian Donovan in his fifth year of In-care commitment included giving him specific feedback on his sermons, prayer classes, and Gregory Wing services; attending meetings with his Committee on Ministry(COM) and his Ordination Interview; helping to edit his Marks of Ministry and his Ordination Paper; writing a Board of Deacons-endorsed recommendation to his COM; and beginning the planning for his Ecclesiastical Council which is to be held in our sanctuary in January 2020.

Deacons also recommended and endorsed the hiring of our first AV Technician, Tom Dewey, in July 2019. Tom and the AV Committee have ably continued to develop the new streaming ministry, greatly expanding our outreach to those unable to attend church services in person. New equipment was added this year, and there are additional plans to expand the AV closet and re-organize and add equipment that will address some of the technical issues we have experienced.

With Heather's help, the Deacons ratified and adopted Music Copyright Policies and Procedures to be used by the church going forward.

Deacons also:

- Oversaw the ordering and arranging of Easter and Christmas flowers for the holidays and distributed them to members of the congregation afterwards. Christmas wreathes were purchased and hung on the doors. A spectacular Christmas tree, paid for by a fund established by Jackie and Pete Mundy, was installed in our sanctuary.
- Sent gift cards to our youth attending college and organized a Baccalaureate Reception for the graduating BRHS Class of 2019.
- Welcomed ten new members into the church over the year, including two confirmands.
- Organized the third outdoor service at Barrett Park, and participated in an ecumenical World Day of Prayer Service spotlighting the country of Slovenia.
- Deacons helped plan and implement Sarah's Service of Farewell, the Reception which followed, and the collection and presentation of the Love Fund formed in her honor. They also arranged the pulpit supply following Sarah's departure, as the Executive Committee began its search for an Interim Minister: Tom Lenhart in November and Ken Bradsell in December, with Brian Donovan taking the 4:30 Family Service on Christmas Eve. In the new year, Deacons will continue to organize pulpit supply as necessary during this time of transition.
- The Board of Deacons want to honor and thank retiring Deacon Co-chair, Tom Knobloch, and retiring Deacon, Laura Honey, for their significant contributions and exemplary service to the church over the past six years.

Board of Trustees

The Board of Trustees meets monthly to manage the business and financial affairs of the church as well as look after the physical plant and the grounds. Following are the highlights of the Trustees' work for 2019.

- Plantings at the overflow parking lot
- Finishing plantings and dedication of the Memorial Garden
- Installation of new programmable locks for the exterior doors of the building
- New AV monitor at the back of the church for the choir

A huge thank you to Jon Dunsford and Tom Blake for their work in keeping the building in great shape, and to Eric Hakanson for his work with the security company this past year.

The Trustees met with the Deacons to discuss and plan implementation of security procedures for the church. The new systems are up and running and providing additional security for our staff and all who use the church.

Tom Dewey was hired as the A/V Technician, providing needed continuity and expertise for our streaming capability. He is aided by a stalwart team of volunteers. Plans are in progress to design and build an expanded A/V room to accommodate additional equipment and people. Live streaming of our Sunday morning service has become an important part of our outreach to all who cannot attend in person on Sunday mornings. Thank you to the A/V Committee and Trustee Jeff Long for this important work.

Financially the church continues to be in good health. Treasurer Jeff Long reports to the Board monthly noting that expenses for the building were up this year while revenues remain strong. A generous gift from an anonymous donor has allowed the church to complete several wish-list projects as well as provide the funds for expanded music in the Sunday School, allow the garden planting to be completed, replace crumbling steps at the Murray Entrance, and continuing scholarship awards. The scholarship for 2019 was awarded to Ashly Abbott. Congratulations, Ashly! A good year for the stock market benefited our Endowment. Thanks to the Investment Committee members for their ongoing monitoring and work with our investment professionals.

The Trustee Treasures Table at the Church Fair was capably handled this year by John and Becky Welsh with help from Dale Lancaster. Organizing and displaying the many donations to sell is a big job, and we are grateful to the team who made it happen this year. The Trustees are considering a new project for the Fair next year. Stay tuned!

We say goodbye to two Trustees this year. Bob Hilscher retires from the Board having served long and well, including three years as Senior Trustee and a year as Board Secretary. We will miss your institutional memory and attention to detail, Bob. Thank you for your service. Bob will continue to serve the church as Moderator. Eric Hakanson is leaving the Board having been a huge help as we installed the new security locks. Eric has shared his experience and advice and been especially valuable in working with the church staff. Thank you, Eric, for being a loyal and valued Trustee. In 2020 we will welcome new Trustee John Hochstein to the Board and look forward to working together.

The Trustees remain grateful to our entire church staff, particularly now as we transition to an Interim and then a new Settled Pastor. They are such a talented and dedicated group that it is a pleasure to be on their team. Heather, Kathleen, Genie and Magen are essential for continuity and guidance to our Interim Pastor as we begin a new chapter in the ongoing life of the church.

We joined the Deacons and all the church family in saying goodbye to our dear Sarah in October. Sarah inspired us all to be the best we can be through her sermons, her guidance, and her tireless energy throughout our community. We will miss her greatly. As we move forward, we will work with and support the Executive Committee in its challenging work as it guides the church through the transition process and search for our new pastor. We look forward to the challenges ahead, and we stand ready to do God's work in this special place we all call home, ever guided by the life and words of our Lord, Jesus Christ.

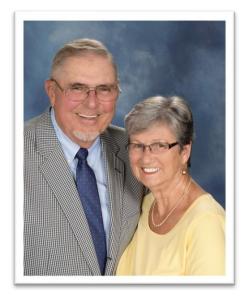

"We are honored and pleased to serve the church in this capacity. As you may know, The John Murray Society was established to provide a conduit for those members who have the financial means and desire to leave a portion of their estate to the church. Regular offering, from yearly pledges and other donations collected each Sunday, cover most of the operating expenses. Society Funds, when not directed for a specific purpose, may be used for capital projects and the general advancement of the Christian faith. There are pamphlets explaining the many ways to make a bequest, which can be found in the church library. Please feel free to contact us if we can be of assistance."

Stewardship Committee

Our committee started its work in late August 2019. David Eastwood continued as chair. We decided to build on the theme of "God is able to provide you with every blessing in abundance... so that you may always have enough" (RSV II Cor 9:8).

November 17 was selected as Stewardship Sunday. Initial appeal letters were mailed to members and friends in early October, and reminder letters were sent to those who had not pledged as of November 19. Updates were provided to the congregation through announcements during Sunday services, bulletins, and the Cross and Anchor.

As of January 9, 2020, the church received 126 pledges totaling \$260,038. Last year, the church received 136 pledges amounting to \$261,680. The average pledge decreased from \$2,076.83 for 2019 to \$2,064 for 2020.

The committee thanks everyone who pledged for 2020. Pledges are so important to the church in creating an operating budget for the coming year. Considering all the activities of the church in the community, as well as for members and friends, pledging is essential for creating an operating budget that reflects the church's ability to function as part of the Christian community.

Thank you, also, to those who completed and returned the Time and Talent cards. Heather Lorrain, Church Administrator, has entered the information into the church database to provide better access and use.

The committee's work was greatly facilitated by the church's staff. Our church administrator, Heather Lorrain, and bookkeeper, Kathleen Humphrey, did excellent work on behalf of the committee. They produced the stewardship drive materials and recorded the pledges and Time/Talent cards, and it has been very easy to work with them.

Missions Committee

The Missions Committee had an active and fulfilling year, and worked hard specifically for immigrant relief, among other projects. We donated a total of \$44,201, which equals 12 percent of realized pledges as well as moneys raised in our fundraisers – the Church Fair, and special fundraisers for local Coast Guard personnel and immigrants.

Mission Moment: We have a very special Mission Moment in October when the Rev. Justin Meyer spoke of the work of the Al Amana Center in Oman.

Coast Guard Station: Personnel at our local Coast Guard station were impacted by the government shutdown at the beginning of 2019. We responded in January with a fundraising breakfast and raised a total of \$6950 for the Coast Guard Chief Petty Officer fund, to be distributed by them for humanitarian relief.

Refugee relief: We reached out to the Sudarita (Arizona) Congregational Church, a congregation involved in work along the border, and held a fundraising breakfast in May that raised \$2121 for their Good Samaritan program. We also collected and shipped several boxes of toiletries to the program. We also raised \$5015 for ILAP – a nonprofit that provides pro bono legal support for refugees here in Maine.

Welcome the Stranger/International Workers Welcome: We held our annual Workers Welcome in June. Increasingly, it is clear that the workers who come are less interested in eating at the event, and more interested in food to take for consumption later as well as general information about the Region.

Hurricane Fundraiser: After Dorian hit the Abacos, a group within the church pulled together a fundraising breakfast to help with humanitarian relief. This was not the work of the Mission Committee – we appreciate that so many others in the church are eager to pitch in!

Author, Author! Local author Sarah Stone, who wrote a memoir of her family's personal experience during the Holocaust, came to the church on October 17. She spoke to us about her family, read excerpts from the book, and we served refreshments.

Trip Opportunities: We researched the possibilities of a trip to help out at the border, and also a second trip to Oman, but despite considerable interest, not enough church members could set aside the time and funding. These opportunities may be revisited at a later time.

Christmas Fair: We sold craft items and home heating oil gift cards at the Christmas Fair. All our items sold were donated – we did not have any upfront costs. The results: \$215 for Local Missions; \$91 for the Carpenter's Boatshop; and, \$2725 for home heating oil gift cards.

Local Missions: With Sarah's retirement, the Local Missions checkbook has reverted back to the Mission Committee. Marcia Bradsell is now managing that account, with Bill Prince as her backup.

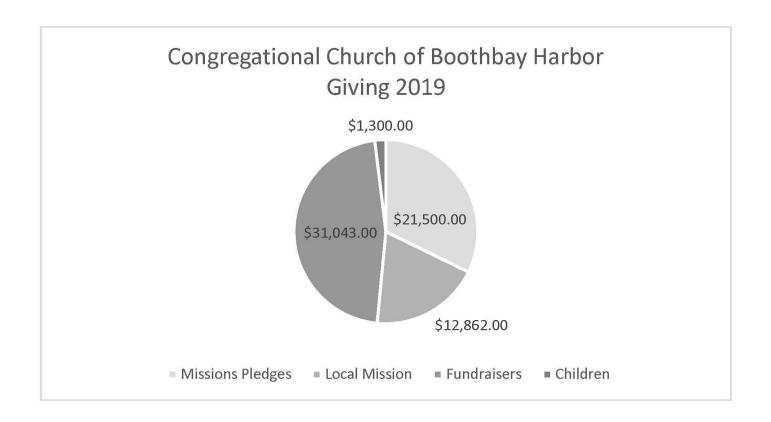

History & Archives Committee

In July of the Year 2019 under contract, the Maine Historical Society (MHS) took temporary custody of 25 linear feet of BHCC records, including manuscripts, scrapbooks, photographs, ephemera, printed matter, artwork, and even architectural drawings. The MHS professionally processed this collection of materials, and in the fall of 2019 returned collection as an "Archive," one, using the society's own words "produced with the same care and safekeeping as the MHS' own collection" [found on Congress Street in Portland next to the Longfellow House]. Presently, our archived church records are stored in acid-free folders and in gray archive-quality gray boxes in the Church Library. While some of our records are stored in fire-proof cabinets, too many are shelved unprotected from a fire hazard. We hope to begin addressing this issue in the year 2020.

In late 2019 the History and Archives Committee met with Dr. Sarah Foulger to discuss the disposition and preservation of the record of her 16-year pastorate of our church. Much of that record existed in cyberspace. Dr. Foulger faithfully produced a hard copy of that record which is now part of our official church record and must be added to the archive. At that same meeting we discussed the church holding of three academic gowns belonging to past ministers of our church, including Dr. Harry Emerson Fosdick, "Rockefeller's Minister." We plan to have Fosdick's gown cleaned and professionally stored and available for display. At that same meeting we also discussed the availability of additional space in our Church Library for storage of future church records.

Finally, the committee noted in 2019 the imminence of the State of Maine's Bicentennial in the year 2020. In 2019 Maine had been a "District" of the State of Massachusetts. Most of the pressure for that District to separate from Massachusetts came from the Southern coastal communities that contained the bulk of the region's population (Brunswick, Portland, York, etc.). How in 1819-1820 did the relatively young Congregational Church of Boothbay feel about that issue? We can try to find out as we commemorate that founding of the state as part of the Missouri Compromise passed in March of 1820. We plan our commemoration in the fall of 2020.

Long Range Planning Committee

During 2019, in an effort to broaden the planning process, the Long Range Planning Committee held three special planning meetings (April 22, June 18 and September 17) with representatives invited from all church committees. Committees were asked to draft their input to the planning process in 1, 3, and 5-year objectives based on our mission statement.

OUR MISSION: The Mission of the Church shall be to teach and preach the gospel of Jesus Christ, to establish a fellowship based on the love of God and humanity, and to further the Realm of God.

This document is a summary of what we heard from the committees at the three special joint meetings and in follow up communication. We have not attempted to prioritize what we heard, but rather to present this information as an overview of the current issues and objectives being discussed by our church committees, thus providing insight and understanding for moving forward.

The Long Range Planning effort has reminded us of the importance for all of us to continue to contribute to the vitality of the congregation and to think strategically for tomorrow.

Diaconate

The Gospel transforms us and calls us in ever new and fresh ways to be a community responsive to the changes around us. How do we support, encourage, grace, and serve those in our congregation and the entire community? To this end planning has framed challenges for us that will need far more reflection and hard work in the days, months and years ahead:

Questions to be answered in the future:

- How do we sustain what we have and continue to be a vibrant presence of Christ in the community, region and beyond?
- How do we assist our members to discover and utilize their many gifts for the ministry of the church and service in the community?
- How do we reach, welcome and embrace younger families into our congregation?
- How does our congregation strengthen its ability to widen and deepen its reach to all who call the Boothbay peninsula home particularly those who feel left out, left behind or forgotten?
- How do we embrace fully the clear Gospel mandate of welcome and hospitality for everyone in everything we do?
- Do we need to do this proactive work together as a congregation? What is this work? Who best can help us on the journey? How can our interim pastor help us?

There was significant discussion during our joint planning meetings around the idea that we should explore ways to further develop a culture of hospitality throughout our church.

- Explore new ways to embrace visitors
- Welcome new members by assigning a mentor family to new members and checking in with new members 3-6 months after they have joined our church
- Resume the previous practice of introducing new members through pictures and bios in the newsletter and add an introduction of new members with pictures in the Sunday bulletin on new member Sundays
- To increase the sense of community, regularize the practice of congregants sharing short stories about their personal faith journey (Grace Notes)

Deacons are adding a new category of summer deacons to include summer or seasonal individuals who are involved with church events when they are here but are away during the winter.

Hospitality & Fellowship

The committee is seeking more participation on the committee and fresh ideas to welcome new members. Ideas and suggestions include:

- During service invite everyone to come downstairs following service...we would love to have you, please join us.
- Increase participation through Time and Talent cards and by pairing new people for organizing the coffee with people who have experience putting on the coffee.
- It was suggested that that the Diaconate and Hospitality and Fellowship focus together on mutual issues of communication, new members and welcome.
- Consider augmenting the committee with summer people
- Work toward the goal of reducing/eliminating the use of plastics in our church in support of the work of Boothbay Region's Committee for a Plastic-free Peninsula (PFP)

Audio Visual

- Expand the AV closet space by three feet
- Investigate ways for the church to control its own streaming over the internet
- Explore ways to advertise and increase awareness of our TV streaming

Trustees

The Trustees reported that they are engaging in a time of introspection, "What will the church be like in the future."

- Who do we want to be?
- Where do we expect to go?
- What do we need to get there?
- How will the Trustees assist the congregation in reaching its developed goals?
- A church profile, to be prepared by the transition committee, will address the above questions and
- The pastoral search committee will be appointed after the interim pastor is onboard.

Suggestions and ideas from the planning process include:

- Trustees are working with the Diaconate on the audio-visual improvements
- Suggest the trustees, in conjunction with the Diaconate, consider adding a church sexton to be available to help with preparations for church events
- Suggest that the Trustees work with the Music Committee to explore ways for better access to the choir loft and pulpit level for individuals with limited mobility

History and Archives

- The History and Archives Committee has worked with the Maine Historical Society to develop professionally preserved records for our church. Additional steps recommended include:
 - Recommend setting up a church policy on the preservation of ministerial records
 - o Recommend setting up a policy for preserving physical historical artifacts
 - Need a process to continue to professionally preserve our future records

Mission Committee

The heart of the Gospel is hospitality, welcoming, caring for, healing and making whole all whom we meet. The Mission Committee does much of the work on our behalf. The committee members also serve as the mentors, challengers and encouragers for all of us to be Christ's presence in the world, this year, next year, and beyond. Together may we continue to be Christ's mission to the least of these and to the ends of the earth.

The Mission Committee wants to continue its efforts to respond to headlines and challenge the congregation to answer its call to be a missional church.

Discussion and recommendations include:

- Encourage the Mission Committee to report annually, all contributions raised "over and above" the budgeted 12% of the congregation's anticipated revenue that is allocated annually to the mission budget. As we understand the plan the "over and above" amount will represent those funds raised through various fundraising activities sponsored by the mission committee and other church organizations throughout the year. The purpose will be to provide the church membership and friends a much clearer understanding of our commitment to mission local, regional and global. The use of an annual pie chart to illustrate total mission giving is in the works.
- Develop a means utilizing existing and available software to maintain a log of volunteer hours contributed to sustaining the mission and outreach ministries of the congregation.

Religious Education and Sunday School

The committee seeks to continue providing exceptional Sunday school, Vacation Bible Camp, and special events for children up to the sixth grade. Long range plans seek to expand these offerings through Jr and Sr High School

The committee is exploring ways to start a mentor program to train new leaders for youth programming

Music

Suggest that the Music Committee work with Trustees to consider ways for providing better access to the choir loft and pulpit level for individuals with limited mobility.

Stewardship

It would benefit the stewardship effort if the committee could be informed of any new events or projects by June each year so that they could be incorporated into the fall stewardship drive. People are more willing to give when they understand the importance and highlights of upcoming projects

Three topics identified in the planning processes which warrant further work and discussion will be explored further in 2020 by the Long Range Planning Committee in discussion with deacons, trustees, committees and the interim pastor.

1. Outreach

Longer range ideas discussed under this heading included how to broaden hospitality through increased outreach in our community.

- How do we position ourselves to outreach into the community, who is responsible?
- Suggested that we consider a hospitality event for our church neighbors
- Input from the music committee could help shape ideas for outreach
- Suggested that we consider more social events throughout the year, including a signature summer
 event
- Should there be a publicity committee in the church to prepare a weekly column about what's going on?

2. Reaching out to the addiction community

- Who could we partner with?
- Suggestions and volunteer leadership are needed to find a way forward with these topics
 - o How can we reach out to the addiction community?
 - Audio visual is a great first step

- Perhaps we could identify a person or congregation with success in reaching out to these folks and invite them to talk with us
- Explore how we could offer a monthly service for the addiction community who
 may not be comfortable in our traditional Sunday service (Opportunity for lay
 leadership?)

3. Reaching out to single moms

• What role should our church play?

Hospitality & Fellowship Committee

Our church was able to donate \$11,000 to the Coast Guard to help in their time of need as they help us when we need them.

Befriender Lay Ministry

The leadership team of Vicki Haugen and Shawn Lewin continue to oversee our team of 12 Befrienders providing an emotional listening lay ministry under the supervision of the minister. We continue to be about 60% active with our group engaged in visits, and all remaining engaged in our monthly meetings. We expect to train more Befrienders as the need arises. The training requires formal assessment interviews, background checks, 20 hours of classroom education, as well as an internship period.

In summary:

- 1. We visit folks connected or belonging to the church.
- 2. We see persons who are able to be supported by and engage in short term verbal conversation during times of bereavement, health issues, relationship changes, or are unable to get out to see friends or get to church. We offer confidential emotional listening rather than social or physical support.
- 3. We encourage all church members to keep aware of persons who might be receptive to having a Befriender Listening Minister.
